



COVID-19 Pool Use Guidelines

ATTENTION ALL GREEN GLEN NEIGHBORHOOD ASSOCIATION RESIDENTS

COVID-19 WARNING

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. By entering and using any Green Glen Neighborhood Association facilities, you voluntarily assume all risks related to exposure to COVID-19.

Maintain 6 feet of space: The Centers for Disease Control and Prevention recommends social distancing to prevent the spread of COVID-19. For your safety, please keep at least 6 feet away from others.

1. No person may access the pool facility if they are experiencing symptoms of illness including a fever of 100°F or above, sore throat, runny nose, chills, sneezing, coughing, abdominal pain or diarrhea, or have had a confirmed case of COVID-19.
2. Persons are required to swim only with family members of their household and use social distancing guidelines keeping at least 6 feet in distance from others.
3. Parties or gatherings are prohibited at the pool and in all common areas.
4. NO GATHERINGS OF TEN (10) OR MORE PERSONS WITHIN THE POOL AREA AT ANY TIME!
5. Use of the spa is limited to one (1) person or members of the same household at any time.
6. Pool furniture must remain six (6) feet apart at all times to provide adequate spacing.
7. Third party swim instructors and classes are prohibited.

GREEN GLEN NEIGHBORHOOD ASSOCIATION pool facility hours of use are **Sunday-Thursday 6:00 A.M. – 10:00 P.M.** and **Friday-Saturday 6:00 A.M.-11:00 P.M.** only. Anyone found using the pool facility outside of the posted hours, will be in violation of the GREEN GLEN NEIGHBORHOOD ASSOCIATION Adopted Pool Use Policy, and will result in enforcement up to and including a duly called hearing, fines, and a 30-day suspension of pool facility use privileges.

The GREEN GLEN NEIGHBORHOOD ASSOCIATION pool facilities are **PRIVATE PROPERTY** and are for the sole use of GREEN GLEN NEIGHBORHOOD ASSOCIATION Residents and their invited guests only. Anyone not a Resident of the GREEN GLEN NEIGHBORHOOD ASSOCIATION found using the pool facilities will be **TRESPASSING**, and will be prosecuted to the full extent of the law.

Neither the GREEN GLEN NEIGHBORHOOD ASSOCIATION nor any of its assigned agents, or third party contracted vendors are responsible for any illness or injury suffered by any person as a result of accessing the pool facility.

If circumstances require, the pool may be closed at any time.

Effective Date: Determined by Governor Newsom's modification of the Stay at Home Order allowing use of the pool.
